Bids are hereby invited from contractors registered on the Central Supplier Database (CSD) with CIDB grading of 4GB or higher class of construction works for the construction of the single and double pit VIP toilets at Dannhauser. The 90/10 preference point system will be applicable as prescribed in Amajuba District Municipality Supply Chain Management Policy.

Bidders are required to submit original valid B-BBEE Status Level Verification Certificate(s) or certified copies and original sworn affidavits thereof together with their bids, to substantiate their B-BBEE rating claims. Failure to submit the B-BBEE verification Certificate or sworn affidavits will result in forfeiting the points by the bidder
